AMENDING TITLE 20, CHAPTER 4, ARTICLE 3, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-841.14; AMENDING TITLE 20, CHAPTER 4, ARTICLE 9, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1057.20; AMENDING TITLE 20, CHAPTER 6, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1376.11; AMENDING TITLE 20, CHAPTER 6, ARTICLE 5, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1406.11; RELATING TO HEALTH INSURANCE.

6 SERVICE CORPORATION THAT ISSUES SUBSCRIPTION CONTRACTS MAY NOT IMPOSE
7 COPAYMENT OR COINSURANCE REQUIREMENTS FOR EMERGENCY CONTRACEPTION THAT IS
8 PRESCRIBED BY A HEALTH CARE PROVIDER OR THAT IS ISSUED THROUGH A STANDING
9 PRESCRIPTION DRUG ORDER AUTHORIZING THE DISPENSING OF EMERGENCY
10 CONTRACEPTION.

33 FOR EMERGENCY CONTRACEPTION THAT IS PRESCRIBED BY A HEALTH CARE PROVIDER
34 OR THAT IS ISSUED THROUGH A STANDING PRESCRIPTION DRUG ORDER AUTHORIZING
35 THE DISPENSING OF EMERGENCY CONTRACEPTION.
